TreeHouse Foods, Inc. (NYSE: THS) is voluntarily recalling certain Chewy Granola Bars sold under the brand name Signature Select.

This recall is being conducted because the outer carton indicates that the product is Chocolate Chip variety, while some of the individually-wrapped product contained in the carton may be Peanut Butter & Chocolate Chip variety. People who have an allergy or severe sensitivity to peanuts run the risk of serious or life-threatening allergic reaction if they consume this product.

Product was distributed nationwide through the following stores: ACME Markets, Albertsons, Albertsons Market, Amigos, Andronico's Community Market, Carrs-Safeway, Eagle, Haggen, Jewel-Osco, Lucky (limited to stores in Utah), Market Street, Pak N Save, Randalls, Safeway, Safeway Community Markets, Shaw's, Star Market, Tom Thumb, United Express, United Supermarkets and Vons (limited to stores in Fresno, Clovis and Oakhurst).
