**Appointment of Dissolution and Family Mediators -  
Child Custody, Financial, Relocation and Visitation**

Pursuant to Illinois Supreme Court Rule 905(b) and Eleventh Judicial Circuit Rule 154, the attached list of individuals have completed the requisite training to become mediators within the Eleventh Judicial Circuit in Dissolution (D) and Family (F) cases, and have been certified by the Office of the Chief Judge to mediate issues of custody or the allocation of parental responsibilities; relocation of a child; or visitation or parenting time issues.

Further, those persons listed as financial mediators may conduct mediation on financial and property issues in Dissolution (D) or Family (F) cases.
